NAACP Papers, Part II, Personal Correspondence of Selected NAACP Officials

The Personal Correspondence of Selected NAACP Officials is a selection made by Library of Congress archivists of Association materials deposited at the Library. It does not include the complete personal correspondence of any of the officials but only that which was left in NAACP office files. In theory, the materials are not directly related to the officers' official duties at the Association, but that line of demarcation is not always rigid. Much of the correspondence, for example, is among the officials themselves with ample commentary on Association policies and goals. These instances include writings on the legislative (particularly Federal antilynching legislation), branch organization, and administrative issues with which the NAACP grappled prior to 1939. Likewise, much of the correspondence of Association attorneys offered here refers to NAACP legal redress activities and pending litigation.

Nevertheless, the general pattern running throughout this selection is correspondence between Association officials and their friends and relatives, with other civil rights and reformist organizations, with publishers, editors, and literary correspondents, with journalists and academicians, and, in the case of attorneys Thurgood Marshall and Charles Houston, with clients, fellow professionals, and professional associations (such as the National Bar Association and the Lawyer's Guild). The selections also contain responses to speaking invitations, to requests for employment at the Association or help with employment elsewhere (particularly in the depression years), and to random inquiries from the public and from Association members. In some cases, there are also personal financial records, expense accounts, appointment books, along with rough drafts of articles, speeches, and book reviews.

The office diaries are, like the Personal Correspondence, a collection of what was left in Association files and not necessarily a complete record. They are most complete for 1919 and 1920, break off entirely after 1921, with only the diary of Walter White—then the Association's Executive Secretary—appearing again in the late 1930s. Unlike the correspondence, however, the diaries are not only those of NAACP officers but of a number of lower-level office workers as well. They thus provide insights into the activities of the Association's National Office from the lower to the upper levels.

Charles H. Houston was the Association's first paid, full-time Special Counsel at the National level. His tenure at that position spanned 1934-1939. The selections presented here include: correspondence with former law students and faculty colleagues of Howard University Law School, with his father and law partner, William Houston, with the National Bar Association, the Lawyer's Guild, and other legal-oriented associations such as the American Civil Liberties Union. There is also a fair amount of correspondence with other practicing civil rights attorneys, including many black attorneys working along those lines.

Juanita Jackson was Special Assistant to the Executive Secretary between 1937 and 1938. The focus of her correspondence contained here is with religious, missionary, and social work organizations, including the American Friends Service Committee, the National Training School for Women and Girls, the National Council of Methodist Youth, and others—including many individual social workers. There are also records of her speaking and social engagements.

James Weldon Johnson was the National Field Secretary (1916-20), Acting Secretary (1920), and ultimately Secretary (1920-30). Almost all of the selection offered here which does not pertain to social engagements is literary correspondence with publishers, aspiring poets, and literary groups.

Thurgood Marshall was an attorney for the Baltimore Branch of the NAACP in the early 1930s, moved to the National Office as Assistant Special Counsel to Charles Houston in 1937, and succeeded Houston as Special Counsel in 1939. Much of his personal correspondence focuses on his private practice in Baltimore, civil rights litigation through the Baltimore Branch, and communication as a Branch attorney with the National Office. Large parts of this selection also deal with Marshall's efforts in support of Federal antilynching legislation in the mid 1930s. There are also separate file groupings containing his correspondence with Charles Houston, with the National Bar Association (and as a Bar Association official), and with clients in individual court cases. Of considerable significance are Marshall's personal records of major civil rights litigation he undertook in regard to the Baltimore County Public Schools and University of Maryland. (It must be noted, however, that these are not the complete official Association records on these cases which is contained in Legal Files I-D-45 [Baltimore Co. Public School Case] and I-D-93-94 [University of Maryland Case], which University Publications of America plans to publish as part of its legal redress supplements.)

E. Frederick Morrow was National Branch Coordinator from 1938-44. Much of the correspondence here concerns Morrow's home state, New Jersey, where topics of the letters involve grammar school segregation, textbook selection, discrimination in civil service appointments, and the functioning of the New Jersey state NAACP. There is also a considerable amount of correspondence with national-level officers and on the national goals and policies of the Association. Also included are drafts of newspaper articles and speeches, travel schedules, and a travel log for 1939.

Mary White Ovington was Secretary (1911–12), Acting Secretry (1916), Acting Chairman of the Board (1917–18), Chairman of the Board (1919–1932), and Treasurer (1933–47). Much of the selection pertains to literary correspondence and efforts to promote Ovington's book, *Portraits in Color.* There is also a broad range of correspondence with journalists, academicians, reform organizations such as the YMCA, missionary societies, social work organizations, and philanthropic foundations, particularly the Rosenwald Fund. Beginning in 1932 the corespondence with Walter White and other NAACP officers regarding Association operations becomes sizable.

William Pickens was Field Secretary (1920-1938) and Director of Branches (1939-41). Much of the correspondence is with academicians and with Negro fraternal and civil rights organizations of which Pickens was a member. There is some literary correspondence, particularly as regards the promotion of Pickens's book, *American Aesop*. Much also refers to speaking and social engagements.

Walter F. White was Assistant Secretary (1918–29), Acting Secretary (1929–30), and Secretary (1931–35). A vast amount of the selection for the 1920s is in the nature of literary correspondence, much of it dealing with "Harlem Renaissance" activities, attempts to promote White's books, Fire in the Flint and Rope and Faggot, and communications with renowned authors such as Rebecca West, Sinclair Lewis, and many others. There is also a large amount of correspondence between White and such "Harlem Renaissance" figures as Paul and Essie Robeson, Roland Hayes, Countee Cullen, and Langston Hughes which continues through the 1930s, after much of the other literary correspondence trails off. Also extending from the 1920s through the 1930s is White's voluminous correspondence with book publishers and editors and with editors of popular periodicals (such as The Nation, The New Republic, and The American Mercury).

After 1930, the material tends to be more political and to focus more on Association activities. A list of major topics would include the Scottsboro case, the Crawford extradition case, the internal Association controversy over W.E.B. Du Bois's voluntary segregation theories, and above all, efforts to enact Federal antilynching legislation. Still other valuable correspondence covers possible political activity in the campaign of Al Smith, reports on racial abuses during the Arkansas flood and Levee construction project, and efforts to expand job opportunities for depression-stricken blacks through federal and state civil service. Also significant among the 1930s correspondence are White's communications with philanthropic foundations—including the Rosenwald, the Russell Sage, the Guggenheim, and others—and his efforts to secure support from such sources for black artists such as Langston Hughes.

Other significant clusters of material would include records of social and speaking engagements, correspondence with other Association officials, particularly Joel and Arthur Spingarn, rough drafts of magazine articles and book reviews, and a few annual office diaries (for 1932, 1933, and 1934).

Roy Wilkins was Assistant Secretary (1932-51), Acting Secretary (1951-54), and Secretary (1955-78). He also served as editor of the Association's official organ, *The Crisis* (1935-55). Much of the Correspondence collected here is between Wilkins and fellow journalists. There is also some editorial-related correspondence regarding *The Crisis*.

Office Diaries: As distinct from the "personal" nature of the correspondence files, the Office Diaries reflect the official activities of Association employees during the years they cover. The diaries were kept by lower-level office workers as well as by the Association officers during the early 1920s. This is not necessarily a complete collection of office diaries but only those which were left in the NAACP collection deposited at the Library of Congress. There are two diaries for Walter White in 1938; apparently each was the record of the work of a separate secretary working under Mr. White that year. Other office diaries for Walter White during the 1930s can be found in his personal correspondence files.

In order to maintain uniformity in scholarly reference of these materials, UPA strictly follows the Library of Congress filling system. File Boxes and file designations are noted in the user's guide.

Finally, because the original materials were of most uneven quality, there may be some documents which are more legible to the naked eye in the original at the Library of Congress. UPA efforts to improve upon the darkness of some extremely light materials has, on some reels, compromised the clarity of the frame counter, and in a few rarer cases compromised the clarity of extremely dark or inky materials. Usually, however, these technical compromises can be corrected through the use of a more modern, precisely focused microform reader. Every technical effort has been made to produce the most legible copy possible.
